### MANDATORY DISCLOSURE CHECKLIST

Pursuant to Rule 12.285, Florida Family Law Rules of Procedure, each party to a family law action is **REQUIRED** to provide certain financial disclosures.

Once you have gathered the documents, share them with us using the Google Drive link that we provide you. This method is the most cost-effective way to share documents. This link provides instructions on how to use Google Drive:

If you cannot use Google Drive, you may send the documents via e-mail to <u>assistant@heatherbryanlaw.com</u> or bring documents to the office.

Once all the documents are uploaded, please send us a message through the Portal letting us know that your mandatory disclosures are complete. Again, these are REQUIRED. If you do not have an item in your possession, you are required to obtain the item. For example, to obtain your previously filed taxes, you may request them at <a href="https://www.irs.gov/individuals/get-transcript">https://www.irs.gov/individuals/get-transcript</a>. If you do not have certain items because they just do not exist, for example, stocks or a retirement account, then please let us know in your message which items do not exist.

Finally, the documents MUST be the actual document requested. For example, if a credit card statement is requested, you must provide the pdf statement, NOT A SCREENSHOT. And, ALL pages of the statement must be provided, not the first page.

- 5. If you do not have any documentation or proof of income, you MUST provide a written statement explaining your income over the past 6 months

   Financial aid forms
- 7. 3 years of the following types of property documents:

  Deeds for every property/home you have an interest over the last 3 years

  Leases for every property/home/apartment you have an interest over the last 3 years

  Contracts (formal or informal) for any money owed to you over the last 3 years

### 8. 12 months of banking statements:

Banking statements

Savings statements

Money market statements

CD statements

### 9. 12 months of brokerage account statements:

All brokerage account statements

This is any account in which you buy/trade securities/stocks/bonds

You must provide documentation whether or not the account has been closed and whether or not the account is held jointly with any other person.

## 10. 12 months of retirement statements AND the Summary Plan Description:

Profit sharing statements

Deferred compensation statements

Pension plans

(IRA, 401(k), 403(b), KEOGH, etc.)

You must provide documentation whether or not the account has been closed and whether or not the account is held jointly with any other person.

#### 11. 12 months of virtual currency transaction statements:

Venmo

Zelle

Cash App

Apple Pay

#### 12. Insurance information:

Declarations page

12 months of statements

Certificate of life insurance policy

Copies of front/back of health and dental insurance cards for parties and dependent children

Benefits Cost (per pay period)

2020 business tax return

2021 business tax return

2022 business tax return

14. 24 months of debt statements:

Credit card statements

Student loan statements

Car payment statements

Mortgage statements

Any debt that you owe statements

You must provide documentation whether or not the account has been closed and whether or not the account is held jointly with any other person.

- 15. Prenuptial or Postnuptial agreement
- 16. Any documents that support a claim that certain asset or liability is non-marital OR that there should be an unequitable distribution of marital property
- 17. Court orders for child support or alimony
